

**REFERENCE:**

The Secretary-General of the United Nations presents his compliments to the Permanent Representatives of Member and Observer States to the United Nations and has the honour to refer to the 2008 Convention on Cluster Munitions (hereinafter the Convention) and to resolution 70/54 entitled “Implementation of the Convention on Cluster Munitions”, adopted by the General Assembly on 7 December 2015.

By operative paragraph 7 of the resolution, the General Assembly requested the Secretary-General to continue to convene the Meetings of States Parties to the Convention on Cluster Munitions and to continue to render the necessary assistance and to provide such services as may be necessary to fulfil the tasks entrusted to him by the Convention and the relevant decisions of the First Review Conference.

The Secretary-General has the honour to convene the Seventh Meeting of States Parties to the Convention on Cluster Munitions from 4 to 6 September 2017 at the Palais des Nations in Geneva, Switzerland, and to invite the participation of all States Parties to the Convention. The Secretary-General also has the honour to invite States not parties to the Convention to participate in the Seventh Meeting of States Parties as Observers.

The Secretary-General wishes to remind that, in accordance with Article 14, paragraph 1, of the Convention, “the costs of the Meetings of States Parties [...] shall be borne by the States parties and States not party to this Convention participating therein, in accordance with the United Nations scale of assessment adjusted appropriately”.

Further information on the arrangements for the Meeting will be communicated to the Permanent Missions by the Secretariat of the Seventh Meeting of States Parties in due course.

The Secretary-general wishes to draw attention to operative paragraphs 4 and 5 of General Assembly resolution 71/45, adopted by the General Assembly on 5 December 2016, which urges all States parties to provide the Secretary-General with the information required under article 7 of the Convention and invites all States that have not ratified the Convention or acceded to it to provide, on a voluntary basis, information that could make the clearance and destruction of cluster munition remnants and related activities more effective. This information should be directed to the Office for Disarmament Affairs at the address indicated above no later than **30 April 2017**.

The Secretary-General of the United Nations avails himself of this opportunity to renew to the Permanent Representatives of Member and Observer States to the United Nations the assurances of his highest consideration.
