Re: Convention on Cluster Munitions / Article 7 reporting

Your Excellency,

Your state adhered to the Convention on Cluster Munitions (hereafter referred to as "the Convention"). According to Article 7 paragraph 2 of the Convention, each State Party is required to submit no later than 30 April of each year, an annual transparency report, covering the last calendar year (from the 1st to the 31st of December), and containing updated information on measures taken to implement the Convention.

In the Vientiane Action Plan 2010 - 2014, the States Parties agreed to

- "Fulfill their obligations to annually update Article 7, and where relevant Article 3, paragraph 8, transparency reports and maximize reporting tool to assist and cooperate in implementation, particularly in cases where State Parties must take action to destroy stockpiled cluster munitions, clear cluster munitions remnants, assist victims or take legal and other measures referred to in Article 9", Action 59;
- "To the extent possible, take full advantage of the flexibility of the reporting process, to provide information on matters not specifically required but which may assist in the implementation process and in resource mobilization", Action 60

In September 2012, States Parties to the Convention highlighted in Oslo the continued importance of reporting and transparency obligations in the fulfillment of the Convention's obligations. At the same meeting a "Guide to Reporting" was proposed to assist States Parties in submitting their reports. This "Guide to Reporting", together with the reporting forms, is available at the website of the Convention (http://www.clusterconvention.org/documents/transparency-reports/) and States Parties are encouraged to take full advantage of this tool.
