<p><b>Article 4 - Clearance and risk reduction education</b></p> <p>Clearance obligation deadline: 1 November 2023</p> <p>Estimated contaminated area: 162.8 million m<sup>2</sup></p> <p>Cleared 5.7 million m<sup>2</sup> and released 8.4 million m<sup>2</sup> in 2020</p> <p>Expressed intention to request for deadline extension due to challenges such as large size of contaminated area and lack of working capacity in survey and clearance</p>
