LEGALBASE: Convention on the Rights of Persons with Disabilities of UN

Article 4 General Obligations

Paragraph 3.

In the development and implementation of legislation and policies to implement this Convention, and in other decision-making on issues related to persons with disabilities, States Parties shall closely consult with and actively involve persons with disabilities, including children with disabilities, through their representative organizations.

Article 33. National implementation and monitoring

Paragraph 3.

Civil society, in particular persons with disabilities and their representative organizations, shall be involved and participate fully at all levels of the monitoring process.
