

## **United Nations Inter-Agency Coordination Group on Mine Action Eleventh Meeting of States Parties to the Convention on Cluster Munitions**

## Statement on Victim Assistance Geneva, 12 September 2023

## Delivered by UNMAS

Mr. President,

The following statement is delivered on behalf of the Inter-Agency Coordination Group on Mine Action (IACG-MA)<sup>1</sup>, comprising United Nations entities engaged in mine action.

The United Nations would like to thank the coordinators on Victim Assistance, Austria and Chile, for their work towards the implementation of Article 5 of the Convention.

In the words of the United Nations Secretary-General, "there are more than one billion people with disabilities in the world. Realizing their rights is a matter of justice and investment in our common future. It is also central to realizing the core promise of the 2030 Agenda to leave no one behind."

To call attention to the rights and needs of victims, in December 2022 the United Nations appointed Mr. Giles Duley as Global Advocate for Persons with Disabilities in Conflict and Peacebuilding situations. Mr. Duley will complement the work of the Special Rapporteur on the Rights of Persons with Disabilities and will advocate for the

universalization of the Anti-Personnel Mine Ban Convention, the Convention on the Rights of Persons with Disabilities and the Convention on Cluster Munitions.

In early 2023, the UN endorsed an International Mine Action Standard on Victim Assistance, which was developed in consultation with relevant stakeholders, and which clarifies the roles and responsibilities of mine action actors in victim assistance. We hope it will be a useful tool in achieving the objectives of the Convention.

Over one third of United Nations mine action programmes are engaged in victim assistance services. They most frequently provide orientation and referrals, and when funding is available, complement national efforts to facilitate access to a broad range of services and develop victim assistance policies.<sup>2</sup>

The United Nations urges Member States to provide appropriate care and ensure the full and dignified reintegration of victims in society, including through the dedication of resources and enhancement of capacities.
